Activities:

The First Separate Company was organized in Los Angeles and, on December 3, 1917, was mustered into the California National Guard as Company A, California Infantry. James L. Irwin was chosen Captain, and Anthony T. Swensen, First Lieutenant. The separate units that were organized during the World War encountered considerable difficulty in maintaining strong companies during that period. This condition was due to a lack of interest in the National Guard at that time, as well as to the fact that many members of the separate companies were drafted into Federal Service. Captain Irwin secured a three months leave of absence and left for Washington in March 1913 to try to gain entrance into an officers school. He enlisted in a Remount training school in order to secure a commission in the Army. He tendered his resignation as Captain of First Separate Company on June 21, 1918. Two months later on August 30, 1918, First Lieutenant Anthony T. Swensen also resigned, and the company was without a commanding officer. Lieutenant Michael J. Lannon of the Fourth Separate Company was assigned to the First Company on August thirtieth, and commanded the unit until the First Separate Company was discontinued October seventh. Lieutenant Lannon returned to the Fourth Company October 8. 1918.

Activities: (Continued)

The First Separate Company participated in one parade, that of May 30, 1918 in Los Angeles. Only 21 enlisted men and one commissioned officer participated. About four months later the following order was issued by the Adjutant General's Office:

"The First Separate Company, California Infantry,
National Guard, Los Angeles, California, having
been so reduced in numerical strength on account
of so many of its officers and enlisted men having
been inducted into Federal Service by operation
of the selective service law as to make it
impracticable to attempt to recruit the company
to the required strength, the enlisted men of
said company are transferred as privates to the
Fourth Separate Company, California Infantry,
National Guard, and the First Separate Company is
discontinued. This paragraph to take effect
October 7, 1918".

One day later October eighth, the twenty-five men of the First Separate Company were transferred to the Fourth Company, and the unit was discontinued as ordered.
