***Captain W. T. Adel and first Lieutenant John Hartzoke retained their former commissions as of February 16, 1878 and May 26, 1877, respectively, when they commanded the San Jose Zouaves.

Activities:

Company B was formerly the San Jose Zouaves, organized September 30, 1862, and reorganized as a unit of the Second Infantry Battalion, December 12, 1879. However, a Special Order issued eighteen days later on December thirtieth, stated that the Second Battalion was designated the Fifth Infantry Battalion. Therefore, Company B was designated Company B, Fifth Infantry Battalion.*

On January 26, 1880, it was announced by S. W. Backus, Adjutant General, that the Fifth Infantry Battalion of which Company B was a part, showed the largest percentage of attendance at drills for the year 1880. As a reward they received a United States regulation silk flag with staff complete.** The two years following the units reorganization, was spent mainly in drills and inspections.

Adjutant General George B. Cosby gave the target practice report for September 1883 and Major William Simpson, Inspector of Rifle Practice gave it for September 1884. A comparison for the two years is as follows:

Aside from drills, inspections and target practice, the unit took part in the annual and special parades held each year on Washington's Birthday, Memorial Day, July Fourth and Admission Day.

This practically concludes the activities of the unit, as the Battalion of which Company B was a part, was only in existence for approximately five years. Therefore, in accordance with Regimental Order No. 7, Company B, Fifth Infantry Battalion was redesignated Company B, Fifth Infantry Regiment, Second Brigade, August 1, 1885.***
