#### Activities:

Company A, prior to 1890, was known as the Chico Guard, unattached. On February fifteenth of that year the unit became one of five companies which formed the Eighth Infantry Battalion and was designated Company A.

Captain C. B. Swain commanded the company for a number of years and in 1890, received a bronze service medal for eleven years of service in the National Guard. Corporal B. F. Young and Frivate I. M. Terrill, also received service medals for being associated with the National Guard for a period of fifteen years.\* The election of officers on March 26, 1891, revealed the fact that Company A was commanded by the youngest set of commissioned officers in the National Guard of California. Captain Cahill and Lieutenant Burroughs were both twenty-four years of age, while Second Lieutenant Pratt was but twenty-three. These young men proved very capable commanding officers as is shown by the company merits.\*\*

The first activity Company A participated in efter becoming attached to the Eighth Battalion was an encampment held at Chico during August 1890.\*\*\* Another encampment was held the following year at Camp Allan, Santa Cruz from July 18 to 26, 1891. Company A as part of the Eighth Infantry Regiment attended this camp accompanied by the Sixth Infantry Battalion. The members of Company A were thoroughly drilled in battalion and regimental formations. This being the first encampment of its type attended by the members of Company A, they were forced to contend with some very strong competition from numerous other companies. Their efforts were not futile, as an inspection report by A. D. Cutler, Lieutenant-Colonel and Division Inspector, quotes the average merits of Company A as follows:

Average attendance 70.80 per cent (fair)
Inspection 4.00 per cent (good)
Inspection of quarters 5.00 per cent (very good)

There were thirty-six men present from a membership of fiftyone, which was the amallest membership of any company in the
battalion. Therefore, the attendance rating was not a discredit
to the company.\*\*\*\* The unit as a part of the Eighth Infantry

Battalion was highly commented upon by Captain John O'Connell, First United States Infantry for their rapid progress in battalion and skirmish drills. The Captain gave the troops credit for their accurate and intelligent performance of guard duty. The officers and men were also admired for the manner in which they manifested their duties.\*

Aside from the regular weekly drills and parades, Company A also participated in two target practices held during the months of August and September 1890. In the first or preliminary shoot of August, Captain Swain scored thirty-nine points which entitled him to compete in the finals of September. Competition was very keen in the final meet and Captain Swain and twenty-one men of Company A, scored only enough points for Third-class silver medals.\*\*

Company A held a comparatively good attendance rating during the time the unit was attached to the Eighth Infantry Battalion. During 1891 the company's rating, which was based on the monthly drills, never fell below 75.12 per cent, showing the members took a keen interest in all military requirements. At the annual muster and inspection of 1891, held during July, Company a made enother good showing. The degrees of merit at this inspection were based upon the following three requirements:

First - neatness as to person, uniforms, and equipment.

Second - general bearing and soldierly appearance.

Third - knowledge of duties.

The average merit for Company A under these conditions was 4.66 per cent \*\*\* and the average attendance was 98.2 per cent. The regular weekly meetings and drills, constitute the remaining activities of Company A during the time it was attached to the Eighth Infantry Battalion.

During the latter part of 1891, it was decided through the Board of Location and Organization to elevate the Eighth Infantry Battalion to regimental organization. Therefore, on October 31, 1891, Company A, Eighth Infantry Battalion was redesignated as Company A, Eighth Infantry Regiment, Fifth Brigade.\*
