Activities:

Company B was organized on October 10, 1887, as the Colusa Guard, unattached, and on February 19, 1890, was attached to Eighth Infantry Battalion, Fifth Brigade. The company maintained a good rating while in the service as an unattached company and retained the same standards throughout the life of the battalion. As an indication of the merits of the company which was obtained through the monthly drills, the following table is given:

Although the numerical strength and efficiency ratings fluctuated, the average rating gave Company B a record to be proud of.

The first activity of importance that Company B participated in was a Camp of Instruction held at Chico during August of 1890.*

The members of Company B also participated in a preliminary target practice during August 1891. The highest score for Company B was held by Sergeant W. K. DeJarnatt, who qualified for the Firstclass medal. The Sergeant and nineteen men of Company B also qualified for the Third-class medal. The Sergeant also qualified for a Third-class medal in the final target practice held during September. The second encampment that Company B attended was the Camp of Instruction for 1891 at Santa Cruz, held jointly by the Eighth Infantry Battalion and Sixth Infantry Regiment. Company B encamped with the balance of the Sixth Infantry Battalion from July eighteenth to twenty-sixth. The inspection at this encampment was made by A. D. Cutler, Lieutenant-Colonel and Division Inspector. Colonel Cutler complimented the troops on the general condition of their camp. The gounds and company streets were well policed and the entire camp emphasized military character. The camp was also conspicuous for its compact practical appearance and absence of all save military decorations. This was the first time the two organizations had drilled together in brigade formation; the maneuvers not being as well performed as was anticipated. Company B had the highest percentage of attendance in the Eighth Battalion and tied with Company C at inspection of quarters. The

Company B as a unit of the Eighth Infantry Battalion, maintained a good attendance record during the two years it was attached to the battalion.

A decided increase was noted in the attendance record of the company for the years of 1890 and 1891. At the annual muster and inspection held during September 1890, the attendance was 70 per cent, while that of March 1891 records 98.1 per cent.

The Eighth Infantry Battalion was raised to a regimental organization by the organization of Company F of Oroville. Company B, Eighth Infantry Battalion was redesignated October 31, 1891, as Company B, Eighth Infantry Regiment.*
