Ambulance Company No. 2 was arganized and mustered into the State Service at Los Angeles on April 28, 1917. Lieutenant Samuel G. Bay was placed in command of the unit. A correspondent for one of the local newspapers wrote the following account of the muster in ceremony:

*One handred sturdy young californians offered their services to Uncle Sam last night at Norman Hill center. When only fifty-three of these men were called, a silence, so intense that it almost smothered, enveloped the hall. Ambulance Company No. 2 was mustered into the State Service at a minimum war strength, consisting of fifty-three men and five officers. The fifty-three who were called, and who attached their signatures to the roll, were very happy young men, but the other forty-seven were disappointed and downcast. Some of them, robust manly young fellows, were not ashamed even when tears welled up in their eyes. There was no demonstration and each promised to be on hand when the next call was issued, while a few decided to enter other bfanches of the service. Major Frank R. McReynolds, staff officer of the Second Command, California Coast Artillery Corps, was the mustering officer, he having been designated by Governor William Stephens and Adjutant General J.J. Borree. announced that Lieutenant LeRoy Bailey, of the Medical Corps, would be temporarily in command of the Company*.*

Ambulance Company No. 2 remained under command of Lieutenant Bailey until July twenty-fifth, when Samuel G. Bay was commissioned First Lieutenant, and placed in command of the unit.**

On August 5, 1917, the Company was mustered into Federal Service, and redesignated 158th Ambulance Company, 115th Sanitary Train, 40th Division.***
