## Activities:

The Liberty Guard, Company D, was organized in San Francisco, April 17, 1864. The meeting was not conducted with the customary procedure, inasmuch as a First Lieutenant was elected immediately while the Captain was not elected until June third of that year. The company had a membership of fifty-four volunteers. When the required Bond was filed, fifty stand of arms were shipped the unit by the Steamer "Yosemite," July 29, 1864.

In 1866, after the enactment of the Military Law when the National Guard was materially reduced, the Board of Location and Organization was responsible for the reorganization of the Liberty Guard, changing the company's letter from F to D. This change occurred September third of the same year.

There is no doubt of the corps efficiency from the increased membership of fifty-four members at organization to eighty-nine in 1865. In its early years the company was loyal, active and filled with the spirit of patriotism. However, with the conclusion of the War of the Rebellion the corps lost a great deal of its enthusiasm, and finally requested of the Adjutant General that the company be disbanded. In accordance with Captain Dixon's request Special Order No. 70 was issued mustering the Liberty Guard, Company D, out of the State service. The arms and accoutrements were returned to the State soon after disbandment.
