April twenty-third the company was ordered
to:

and went into camp there with companies C,
F, and I of the First Battalion, Seventh
Infantry. The duties performed by Company
A consisted of assisting the local police,
escorting supply wagons to and from San
Francisco, transferring large sums of money
from the United States Mint at San Francisco
to the banks at Oakland. On the twelfth of
May the company was ordered to return to
its home station, arriving there at noon
May thirteenth.†

Company B assembled April 21, 1906, with instructions to await orders to start for San Francisco. The company entrained at San Diego April twenty-third, having been awaiting orders two days.* Arrived in Oakland April twenty-fourth and was stationed at:

Lincoln Park, Oakland.**

The company was detailed to guard refugee camps and supplies in the city of Oakland, and to assist the local police in maintaining order. The company was engaged in performing these duties until orders were received May twelfth to return to their home station. The company arrived at San Diego May thirteenth.

Lincoln Park, Oakland.

The following day the company was transferred to:

Adams Point, Oakland.**

Went into camp at Adams Point with companies A, F, and I of the Seventh Infantry. Performed guard and escort duty, assisting the local police, guarding supply trains and wagons, moving supplies to refugee camps in Oakland and San Francisco. Orders were received May twelfth for the command to return to its home station. The company left Oakland that day and arrived home May thirteenth.

April twenty-third the company was ordered to take station at:

Alameda, California.**

The company went into camp at Alameda and remained there guarding and maintaining order at the refugee camps there and throughout the town. Also acted as escort to supply wagons and assisted the local police in patrolling the city. On the twelfth of May the company was ordered to join the Regiment at Oakland, preparatory to returning to their home station. Left Oakland May twelfth and arrived at home station May thirteenth.

that night. April twenty-third transferred with Companies A, C, and I, of the Seventh Infantry to:

Adams Point, Oakland.**

In camp at Adams Point until ordered to return to home stations May twelfth. The duties in Oakland consisted of patrol and guard duty in conjunction with local police. Furnished details to escort supply wagons to and from San Francisco. Details sent to help guard and escort civil prisoners from Alcatraz Island to county jails in and around Oakland. Also furnished details to escort wagons transferring sums of money from the United States Mint at San Francisco to local banks in Oakland. Broke camp and entrained for Los Angeles May twelfth. Arrived at home station, Los Angeles May thirteenth and dismissed from active duty.

Encamped at Lincoln Park same day. Remained at that station, sending detachments to guard supplies and refugee camps, also assisted local authorities in guard and patrol duties and in maintaining order throughout the city of Oakland until May twelfth, when the company was ordered to return to its home station. Broke camp and left Oakland May twelfth. Arrived at Los Angeles May thirteenth at 5:30 P.M. Company dismissed from active duty.

Also assisted the local police in guard and patrol work in the city of Oakland. On May twelfth the company broke camp and departed for their home station where they arrived May thirteenth and were dismissed from active service.

Company held awaiting orders which were received April twenty-third.* The company then proceeded via Los Angeles to Oakland, arriving at the latter city April twenty-fourth. Went into camp at:

Lincoln Park, Oakland.**

Stationed with five other companies of the Seventh Infantry Regiment at Lincoln Park, guarding supplies, supply wagons and refugees camps. Helped local Police in patrol and guard duty throughout the city. Received orders to break camp and return to home station May twelfth.† Left Oakland that day and reached San Bernardino May thirteenth.

Stationed at that point with five other companies of the Seventh Infantry performing guard and patrol duty in Oakland. Guarding supply wagons and supply depots. Furnished guards for refugee camps. Assisted local police in guard and patrol duty. May twelfth† ordered to proceed to home station. Broke camp and entrained at Oakland that day. Reached home station and dismissed from active duty May thirteenth.

Arrived at Oakland April twenty-fifth at 7:40 A.M. Ordered to report at once for detached service at:

Second and Broadway, Oakland.*

The company was stationed at First and Broadway and Second and Broadway to guard relief supplies April twenty-fifth to May twelfth when orders were received to break camp and entrain for home. Entrained at Oakland that day, arrived at Riverside at 5:00 P.M. May thirteenth. Company was there dismissed from active duty.
