#### Activities:

Company A was originally the <u>Chico Guard that became Company A</u>, Eighth Infantry Battalion and on October 31, 1891, was designated as Company A, Eighth Infantry Regiment, Fifth Brigade. Captain John Cahill was in command of the company when it became attached to the regiment and retained that rank until the election of officers in 1893. Much credit is due the officers who commanded Company A, as during its existence, the company held an excellent record in attendance. The annual Inspection and Muster for the three consecutive years, 1892, 1893 and 1894, show Company A as having a 100% attendance record. The inspectors at the annual target practices also denote a marked advancement in the issuance of yearly medals. Following is a table of the first and last target practice of Company A while attached to the Eighth Infantry Regiments

Company A took part in a Divisional Encampment at Santa Cruz from August 7 to 14, 1892. The camp site was called Camp Columbus in honor of the Anniversary of Columbus' discovering of America. The members of Company A received training that proved inwaluable to them in later years. They were drilled and paraded in company and battalion formation, and maneuvered with all modern equipment.\*

### COMPANY A

Activities: (continued)

Company A was called into active service during the Railroad Strike in 1894. Practically every railway line between the Oregon line and San Diego were unoperated. The State of California was in drastic need of immediate transportation for the fruit crop which was ready for shipment to eastern states. When the state officials decided to use force in obtaining this transportation, the National Guardsmen were called into active service. Colonel Park Henshaw, commander of the Eighth Infantry Regiment, issued orders for the companies of his command to assemble at once. Company A was at that time parading in a Fourth of July celebration. at Chico. The members reported within an hour after receiving the orders. The troops were then issued 20 rounds of reloaded carthidges, preparatory to being stationed at a point several miles north of Chico on the Southern Pacific railroad tracks. There objective was to prevent a trainload of strikers, enroute to San Francisco from Dunsmuir, from reaching their destination. A section of the track was taken up by the members of Companies A and F and a danger signal displayed some distance beyond. Deploys of troops were sent out along the line of Chico Creek with men on either side of the road. A 12-pound Parrot Gun which had been used in the parade was stationed at a point which commanded the track for fully one-half mile. The companies were then assigned positions which they were to have taken at 5 P. M. of the Fourth. However, a few minutes before 5 o'clock, Colonel Henshaw received another order which rescinded the first. He was ordered to dismiss his command and permit the strikers to pass. Fearing an outbreak from strike sympathizers, the latter instructions were fully carried out, and the track repaired and left in perfect condition. However, Company & remained on duty in the vicinity of Chico until July twenty-fourth. The company was then sent to Sacramento where the troops remained on strike duty until July 30, 1894.

#### Activities: (Continued)

The Board of Location and Organization recommended a reduction in the number of companies in the National Guard of California during 1895. The maximum number of companies allowed by the State Legislature was sixty-nine, therefore, Company A was one of the six companies to be affected by the proposed reduction. Companies A and F of the Eighth Infantry, were consolidated and attached to the Second Infantry Regiment, December 9, 1895, and designated Company A, Second Infantry Regiment, Third Brigade.\*
