Activities

Special Order No. 31, Adjutant General's Office, dated April 12, 1921, authorized the organization and muster in on April 20, 1921, of a Coast Artillery Company, to be located in San Diego, California. Captain John F. Winburn, Fifth Company, Coast Artillery Corps, and Captain Luthur G. Thornton, Sixth Company, Coast Artillery Corps, California National Guard, were detailed to make the preliminary inspection and to muster the new Company into the service of the State. As a result of this special order, a Goast Artillery Company known and designated as Seventh Company, Coast Artillery Corps, California National Guard, was organized and mustered into the service of the State of California, April 20, 1921.

Josef D. Lane, First Lieutenant, Fifth Company, Coast Artillery Corps, was assigned as temporary Commander of the Seventh Company, until such time as permanent officers could be appointed.

On May 9, 1921, Walter G. Gastel, Captain, and Clinton B. Smith, First Lieutenant, were assigned to the command of the Seventh Company, Coast Artillery Corps and on the same date, Seventh Company, Coast Artillery Corps, was redesignated Seventh Company, Provisional Battalion, Coast Artillery Corps.

On May 11, 1921, Seventh Company, Provisional Battalion, was inspected for Federal recognition by Robert R. Welshimer, Major, Coast Artillery Corps, U. S. Army, and on July 1, 1921, the organization was redesignated Seventh Company, Coast Defense Command. Coast Artillery Corps, California National Guard.
