These rules and regulations, prepared in the office of The Adjutant General, and under his supervision, have been approved by Governor Hiram W. Johnson. They are published for the information and government of the High School Cadets, with a view to insuring uniformity throughout the Cadet Organization.

icle I.

The Law of the State of California Author ising High School Cadet Organizations.

I. Section I. The male students of any high school in this State, having forty or more such students; fourteen years of age or over, may be organized into a high school cadet company, or companies, of not less than forty members each under such rules and regulations as the governing body of said school may prescribe. Said cadet company, or companies, shall at all times be under the guidance and control of the principal of the said school, whose duty it shall be to make regulations regarding the moral, educational, and physical welfare of said cadets.

SEC. 2. Said companies shall each have one captain, one first lieutenant, one second lieutenant appointed and commissioned by The Adjutant General, State of California, upon the recommendation of the commandant of cadets, herein provided for, and with the approval of the principal, and such non-

commissioned officers and privates as correspond to the non-commissioned officers and privates of the infantry companies of the National Guard of California, the non-commissioned officers to be appointed and warranted by the commandant of cadets, with the approval of the principal.

In case any high school has

SEC. 4. Any commissioned officer, or non-commissioned officer, may have his commission or warrant canceled, and be reduced to the ranks, upon the recommendation of the principal of the high school, for falling back in his studies, or for misbehavior, either in school or in the cadet company, or for other good cause appearing in the judgment of the principal.

SEC. 5. All cadet officers shall be appointed from the senior and junior classes

of high schools.

SEC. 6. Said high school cadets shall have drill in accordance with the infantry drill regulations prescribed by the United States army.

SEC. 7. Said high school cadets shall wear a uniform similar to that prescribed for the infantry of the National Guard of California, except that instead of shoulder straps, cadet chevrons indicating rank, and distinctive collar ornaments shall be worn. The Adjutant General, State of California, is authorized to issue to the high school cadets the required cap and collar orna-

ments, and chevrons. A regulation uniform for cadets shall be kept in The Adjutant General's office to be used as sample from which the uniforms for the high school cadets shall be made.

Src. 8. A sufficient number of obsolete rifles for drill purposes may be purchased by the board of high school trustees, board of education, county superintendent of schools, the state superintendent of public instruction, or The Adjutant General, State of California, out of any funds available and not otherwise appropriated:

Src. 9. Target practice shall constitute a part of the instruction to be given to said cadets, and The Adjutant General, State of California, shall purchase and supply to each of said high schools a sufficient number of Springfield, or other efficient rifles for field target work and for gallery practice, and ammunition and equipment therefor, as in his judgment shall be necessary for efficient rifle practice. All target practice shall be under the supervision of the commandants of cadets or competent members of the national guard or naval militia detailed by The Adjutant General, State of

California. The expenditures therefor may be paid out of the moneys appropriated for the maintenance of the California High Calculates.

School Cadets.

SEC. 10. When necessary, The Adjutant General, State of California, may detail from the organizations of the national guard or naval militia, some competent member thereof who may act as drill and rifle practice instructor for said high school cadets. The Adjutant General may provide for compensating the persons detailed by him to instruct said cadets in drill and target practice.

SEC. 11. Whenever practicable said high school cadets shall be permitted to shoot at target practice upon national guard rifle ranges, when not needed by the national guard under the supervision of the commandant of cadets.

SEC. 12. Said high school cadet companies shall be inspected once each year by officers of the national guard or naval militia detailed by The Adjutant General, State of California, for that putpose. Such inspectors shall report to The Adjutant General the result of such inspections.

Such reports shall be made and forwarded, in duplicate, one copy to the State Superintendent of Public Instruction, and one copy to The Adjutant General's office, and shall bear the indorsement of the principal of said school, containing such remarks as the principal may deem pertinent. Such reports shall also contain an inventory of the state property on hand in the cadet companies at the time of said inspections.

SEC. 13. The principal of the school shall be responsible for all public property supplied to said cadet companies, and shall be the proper care thereof

SEC. 14. The Adjutant General State of California, shall provide suitable drill regulations, books of instruction, and the necessary blank forms for reports of each of said high school cadet companies.

Src. 15. Upon the recommendation of The Adjutant General, State of California, and with the approval of the school board having jurisdiction over the high school, the Governor may commission, in the same

S_{EC} 16. Each and every board of high school trustees, board of education county superintendent of schools and the state superintendent of public instruction are,

and each is hereby authorized, empowered and directed to facilitate the purposes of this act; by co-operating with The Adjutant General, State of California.

SEC 17. All acts or parts of acts in conflict with the provisions of this act are hereby repealed.

Article II.

High School Authority.

2. Nothing in these rules and regulations shall be construed as in conflict with any rule or regulation of any high school, or as revoking any such rule or regulation, or as prohibiting the principal of any high school from making and enforcing any rule or regulation governing the students of his schools that may in his judgment be for the best interests of the students under his control.

rticle III

Organization.

3. Such male students of any high school who are organized in accordance with the provisions of the above law, shall constitute the High School Cadets, State of California; as such they shall wear the pre-

scribed uniform and shall be subject to the orders of their superiors, and to these regulations.

- 4. It is taken for granted that the word or signature of every cadet, worthy to be held in good standing in the high school cadets' organization, will be equivalent to a sacred pledge, or word of honor.
- 5. No cadet shall exercise authority as an officer, or non-commissioned officer, without the approval of the principal of the high school.
- 6. Appointments and promotions for the following year shall be made at Commencement, and thereafter whenever vacancies in the different grades of officers and non-commissioned officers occur. Examinations for same shall be held at such time as the principal may direct. Examinations will be theoretical, except in infantry drill regulations, in which subject they will be both theoretical and practical. They will be of such scope, and held under such regulations, as may be determined by the principal and commandant.
- 7. Appointments and promotions shall be awarded to those cadets who have dis-

tinguished themselves by the performance of all military duties, whose academic standing has been satisfactory, and whose deportment and personal bearing have been such as to create confidence in their ability and steadfastness, and to serve as an example to other cadets.

8. No officer shall hold the office of captain of a company for more than one year. After an officer has held the office of captain of a company for one year, he will be placed on the list of additional officers, and will thereafter be available for such duties with the cadets as may be assigned to him by the principal or com-

9. The vacancies thus created by transfer of captains to the list of additional officers shall be filled in the manner prescribed in paragraphs 6 and 7, article III.

10. The Adjutant General shall select a colonel, a lieutenant colonel, and the necessary commissioned and non-commissioned staff officers for each regiment of high school cadets in the following manner:

(a) Whenever a vacancy in the grade of colonel or lieutenant colonel exists. The

Adjutant General will call on the principal of each school to select from the officers above the grade of lieutenant one candidate. The candidates will be required to compete in examination for promotion. The examination papers will be prepared in the office of The Adjutant General and forwarded to the principal who will appoint a responsible person to supervise the candidates' examination. The candidates' enswers will be returned by the principal to The Adjutant General's office, where the papers will be marked; and the candidate attaining the highest percentage will be commissioned in accordance with section 3, article I.

(b) In like manner the commissioned staff officers will be selected and commissecond from the lightenants.

(c) In like manner the non-commissioned staff officers will be selected and warranted from the non-commissioned officers.

(d) The Adjutant General shall appoint the necessary non-commissioned officers of the regimental band or drum corps.

11. A student who has successfully passed examination for commissioned officers to include the grade of captain shall

receive a certificate of eligibility for promotion to the grade for which examined, duly signed by the principal and the commandant of the school. He will forward this certificate through the principal, to The Adjutant Ceneral, requesting that he be commissioned. The Adjutant General will commission the candidate in accordance with section 2, article I.

12. Between officers or non-commissioned officers of the same grade and date of commission, or warrant, relative rank is determined, first by percentage attained at examination, second by length of service in the high school cadets, third by lot.

13. Any officer or non-commissioned officer who by habitual neglect of his duties as a cadet fails to show sufficient appreciation of his office shall be deprived of his rank.

Article IV.

Registration.

14. Every student, except in schools where military instruction is compulsory, who wishes to become a member of the cadet organization of the school shall regis-

ter his name in the office of the commandant of cadets, and shall at the same time file with the commandant the written permission of the student's parent or guardian. Sion of the student's parent or guardian. The commandant will ascertain from the principal the student's standing in studies and deportment. If this standing is below and deportment. If this standing is below that fixed by the faculty for students in good standing, the student will not be enrolled. Great care will be exercised that only students of good moral character may be enrolled in the cadet organization.

15. No cadet shall withdraw from the cadet organization without the written permission of the principal.

Article V.

Uniform.

16. The cadet uniform shall be that prescribed in section 7, article I of these regulations. Whether breeches or trousers shall be adopted will be determined by the principal and commandant of the school.

17. The pattern of uniform, chevrons indicating rank, cap and collar ornaments, are shown in appendix A of these regulations.

25. The organization, procedure, and records of all courts-martial shall comform to those prescribed by United States a my regulations.

26. No sentence of any court-martial shall be carried into effect until it has been approved by the principal and the commandant.

27. Officers and non-commissioned officers placed under arrest, or against whom accusations of misconduct of such gravity as to warrant trial by court-martial, have been made, shall not exercise the authority of their grade until exonerated.

28. Company commanders shall be held responsible to the commandant for the proper discipline of their respective commands, and shall submit daily reports of all absentees and of all offenses committed by members of their organizations.

29. At the beginning of each term each cadet shall receive a credit of one hundred merits. Any cadet who exhausts his full credit of merits during the term shall be expelled from the cadet organization or otherwise punished as the principal may direct. Any officer or non-commissioned

officer who, during a term, receives a total of fifty demerits shall be reduced.

30. Demerits shall not be given lightly. It must be borne in mind that a demerit materially affects a cadet's general standing in the school. When any officer or non-commissioned officer considers that a cadet should be given a demerit, he shall at once bring the cadet's conduct to the attention of the commandant, and shall notify the cadet that this action has been taken. In every case the commandant shall give the cadet a fair opportunity to explain his conduct to the principal before awarding demerits.

Article VIII.

Conduct and Deportment.

31. No cadet shall address an officer or a cadet who may have reported him for a delinquency on the subject of such report, unless specially authorized by the principal or commandant to do so, and no officer or cadet who has made a report against a cadet shall hold any conversation with him in regard to it, unless by permission of the principal or commandant.

39. Any cadet who shall lose, sell, wilfully damage, destroy, or in any way dispose of the arms, ammunition, equipment, account ments, or furniture issued to him 'all, in addition to paying for the same, be punished according to the nature of his offense.

40. Open manifestations of feeling, by way of approval, or censure, when official announcements are made, is prejudicial to military discipline, and therefore punishable.

41. All combinations under any pretext whatsoever within the cadet organization is contrary to military discipline. Any cadet who, in concert with others, under pretense of procuring redress of grievance, adopts any measure, or signs any paper, or enters into any written or verbal agreement with a view to violate or evade any regulation of the cadet organization, or does anything to the prejudice of good order and military discipline, or who endeavors to persuade others to do the same, shall be dismissed or otherwise punished, according to the nature of the offense.

42. Any cadet who considers himself aggrieved by another, or by an officer, may

complain thereof to the principal or commandant.

43. Articles of War, United States Army, Art. 25. No officer or soldier shall use any reproachful or provoking speeches or gestures to another. Any officer who so offends shall be put in arrest; any soldier who so offends * * shall be required to ask pardon of the party offended in the presence of his commanding officer.

44. Articles of War, United States Army, Art. 28. Any officer or soldier who upbraids another officer or soldier for refusing a challenge shall himself be punished as a challenger, and all officers and soldiers are hereby discharged from any disgrace or opinion of disadvantage which might arise from their having refused to accept challenges, as they will only have acted in obedisence to the law, and have done their duty as good soldiers, who subject themselves to discipline.

45. The above articles of war are included in these regulations.

53. True comradeship is active, not passive. Every cadet should endeavor by good example to encourage his fellow cadet to keep the laws of God and Country.

Article XII

Suggestions.

54. No cadet should appear in uniform on the streets, or in any public place with his hands in his pockets, nor should any uniformed cadet appear except in proper uniform with blouse buttoned throughout. Olive drab shirt may be worn without blouse, in which case it shall be buttoned throughout with collar neatly rolled, except when the cadet is engaged in athletic sports.

55. Cadets who are guilty of culpable and continued neglect of their studies are not worthy cadets notwithstanding any special qualifications they may otherwise possess which particularly fit them for membership in the organization.

56. Cadets should answer promptly and fully every question put by an officer or non-commissioned officer on duty.

57. Every cadet should cultivate politeness. His conduct towards his teachers and towards elderly people should at all times be above criticism.

58. Every cadet should consider himself in honor bound to lend his protection to the weak.

59. Purity in thought, word and deed is the hall-mark of nobility of character. The impure are not wanted in any community.

60. The use of profane or unseemly language is the clearly defined line separating the ill-bred rowdy from the man of gentle breeding. Be careful to keep yourself on the right side of that line.

The Cadet's Glory.

61. A high school cadet is a true gentleman. He stands for the high ideals of life. He loves peace and deplores war, but is always ready to defend his country in its hour of need. He respects authority. He obeys the law. He cultivates filial love,

and strives earnestly to be an honor to his father and mother. He honors the Supreme Being in thought, word and deed.

Article XIII.

Military Instruction.

62. With a view to insure uniformity of drill throughout the high school cadet organization, the United States infantry drill regulations will be the official drill regulations.

63. For instruction in small arms practice the Small Arms Firing Manual, United States Army, is the official textbook

64. For instruction in field service, the Field Service Regulations, United States Army, is the official textbook.

65. The Martial for Non-Commissional Services.

65. The Manual for Non-Commissioned Officers and Privates of the Organized

Militia, is authorized as a textbook.

66. The hours to be devoted to military instruction shall be prescribed by the prin

cipal of the school.

67. There shall be at least two drill periods each week of not less than forty minutes each

Article XIV.

Target Practice.

68. Every cadet shall be taught the nomenclature, care and use of the rifle.

69. As soon as practicable after the enrollment of a student in the cadet organization, he shall be put through the course in gallery practice prescribed for Junior Marksman's Course, National Board for the Promotion of Rifle Practice.

70. Every cadet shall be taught to estimate distances up to 1,000 yards, in accordance with the principles set forth in Smal Arms Firing Manual, United States Army 71. Such outdoor practice, service ammunition, will be held each year as may be

72. The target season is from January 1 to December 31. Gallery practice should be carried on throughout the year.

73. In each cadet company there shall be organized a rifle club under the rules and regulations of the War Department, National Board for Promotion of Rifle

Practice and affiliated with the National Rifle Association of America.

74. Every cadet under eighteen years of age should strive to win the "Junior Marksman's Lapel Button," issued by the war department through the National Rifle Association of America.

75. Annually the rifle club in each cadet organization shall appoint a team to compete for the War Department trophy, interschool championship, and for The Adjutant General's trophy.

76. The time and place for holding the competitions prescribed in paragraph 75, and all rules and regulations governing it, will be announced in orders from The Adjutant General's office.

77. All information relative to the rifle clubs and shooting referred to in paragraphs 73 to 75, inclusive, will be furnished to the commandant of cadets on application by him to The Adjutant General's office.

Article XV.

Military Correspondence.

78. All official correspondence will be carried on in a military manner in accord-

ance with the form prescribed by the War Department.

79. Appendix B will show the form of military communications, letters, endorsements, etc.

80. Letters and endorsements will be couched in courteous language. Impertinent and flippant remarks will be carefully avoided. Violations of this rule will be punished with demerits

81. A communication will refer to one subject only:

82. All communications will be promptly answered. Violations of this regulation will be punished according to the nature of the offense.

Article XVI

83. To each regiment organized in accordance with section 3, article I, there shall be issued one national color and one regi-

84. To each battalion there shall be issued one national color.

85. The national color shall be the national flag of silk, 4 feet fly and 3 feet on the pike; the union to be 22 inches long, with

When not in use as prescribed in this paragraph, regimental and national colors will be kept in their waterproof cases.


Article XVII.




Additions and Amendments.


89. Additions and amendments to these regulations may from time to time be published in orders. Such additions and amendments shall be pasted on the blank pages provided for the same herein.






All chevrons to be of navy blue on same material as the uniform.






CHEVRONS.
