ACTIVITIES:

The Ninth Division, Naval Militia of California, numbering sixty-three men, was organized at Los Angeles and mustered into the service of the State on the nineteenth of November 1914, but no arms or equipment were received until May 1915. As soon as equipment was received the Division became active in Drill on shore and aboard ship. In July 1915, two officers and forty-four enlisted men of the Ninth Division had their first opportunity to practice at sea, when they participated in the annual cruise for that year on board the U. S. S. "Marblehead".*

An aeronautic section consisting of twenty men of the Ninth Division was organized February 3, 1916, and several of the men of that section were sent to Pensacola, Florida, for the purpose of pursuing a three months's course of instruction at the Naval Flying School there. Ensign Frank Simpson Jr. was detailed by the Lieutenant Commander to take charge of the Aeronautic Section. The Division passed a satisfactory Federal inspection April 27, 1916, and on May sixth and seventh enjoyed a short cruise on board the U. S. S. "Farragut" in which two officers and fifty-two enlisted men participated.**

ACTIVITIES: (Continued)

The annual cruise for 1916 was made to Puget Sound on board the U. S. S. "Oregon" August fifth to August nineteenth, and forty-four officers and men of the Ninth Division participated. The Ninth Division served in the State forces only about two and one half years, but during that time made rapid progress and as in the case of the other divisions was a credit to the Naval Militia of California.

The activities of the Ninth Division of the Naval Militia as a State organization terminated in April 1917, for on the sixth of that month the United States declared war on the Imperial German Government, and word was received by Governor Wm. D. Stephens from the National Government ordering the State Naval Force into the Federal Service. The several divisions assembled at their armories and prepared for muster. On April fourteenth six officers and ninety men of the Ninth Division were enrolled in the National Naval Volunteers. They were subsequently mustered in at Mare Island and detailed for duty on board various war vessels and stations throughout the country.
