Battery D, Field Artillery, was organized in Livermore, Alameda County, California, January 31, 1922, and placed under the command of Captain Ralph Meritt.

The following month on February 18, 1922, Battery D, was assigned to the First Separate Battalion, Field Artillery, as Battery D.

On March 23, 1922, Special Order No. 42, was issued, directing that on and after April 1, 1922, Battery D would be known and designated as Battery C.
