### SURVEY OF STATE GUARD OF THE UNITED STATES October 1940 to October 1941.

To The Secretary of War:

One year has passed since the enactment of Public No. 874, 76th Congress, approved October 21, 1940, authorizing the establishment of state military forces to take the place of the National Guard while in Federal service. It seems appropriate at this time, therefore, to present a survey covering the organization and training of these forces, as organized by the several states and variously known as State Guards, Defense Guards, Reserve Defense Corps, Protectico Force, Defense Force, State Defense Corps, Active Militia, State Troops, etc.

This survey includes tables containing pertinent information on State Guard activities as follows:

(1) State appropriations made for organization and maintenance of State Guards.

(2) States not organized, and reasons therefor.

(3) Supply of arms and equipment by the Federal Government.

(4) Items of equipment and supplies purchased by states from the Federal Government and in the open market.

(5) Description of uniforms provided by states.

(6) Active duty performed in civil disturbances and catastrophes.

(7) Organization and Station List.

The training of State Guard units under the supervision of corps area commanders has progressed satisfactorily, with weekly instruction in basic subjects listed in paragraph 11, AR 850-250, as fundamental for State Guards. All state armories are being used by State Guards. Several states have organized units in communities where there are no armories, and in these the local authorities have made available suitable buildings for training purposes.

Inspections of the state of training and condition of ordnance equipment issued by the Federal Government are now being conducted by corps area commanders, and reports covering such inspections will be submitted to the Chief, National Guard Bureau. In addition, reports are submitted monthly by state adjutants general through corps area commanders covering strength, equipment, and training of State Guard organizations to the National Guard Bureau which is the War Department administrative agency and office of record in all matters relating to the State Guard.

State Guards are officered and manned in most part by men already qualified by military training and experience, serving on a purely voluntary basis. The patriotic motives prompting these men to devote their time and efforts toward the defense of their state and country are highly commendable.

The following twelve states have not organized State Guards for reasons stated:

Arizona

The proposed bill for a state defense force failed to pass the State Legislature. State authorities believe that the cost of such a force would be excessive, and that inasmuch as the state contains no large industries or centers of population their police force will be adequate in an emergency.

Arkansas

Military Code or State Law provides that a State Guard may be organized at the discretion of the Governor. The advisability of organizing a State Guard has been under consideration for some time, but no definite action has been taken.

Idaho

Laws of the State of Idaho provide for organization of a State Guard when the governor sees fit. However, state authorities believe that the present situation does not justify the expense of organizing a State Guard, although plans are in effect for organization when necessary.

Iowa

Legislation authorizing a State Guard passed by State Legislature, but state authorities have not deemed it advisable to proceed with organization.

Louisiana

Laws of state authorize organization of a state defense force but state authorities believe that an augmented police force will be adequate. No State Guard is contemplated at the present time.

Montana

State Legislature passed a bill authorizing a State Guard but failed to make an appropriation of funds for organization and equipment. The Governor consequently vetoed this bill.

Nevada

Militia Laws of Nevada authorize "unorganized militia" but the State Legislature of 1941 made no provision for organization of a State Guard and appropriated no funds therefor. State authorities feel that peace and order can be maintained by an augmented police force.

North Dakota

State Legislation authorizing a State Guard passed but carried no appropriation therefor. Organization is not contemplated unless the situation becomes more serious, as the state is largely agricultural and has no large centers of population.

Oklahoma

ŕ

Bill authorizing formation of a state defense force passed by State Legislature, but state authorities feel that the expense of organization is not justified at the present time. The State Highway Patrol has been increased.

Oregon

State legislation exacted in 1941 authorizing formation of State Guard when deemed necessary. However, state authorities feel that their highly efficient police force is adequate, but if necessary, that body will be augmented by personnel from other law enforcement groups under plans now in effect.

South Dakota

State law passed in 1941 but no appropriations were made for the organization or maintenance of a State Guard. Defense Deputies have been organized in each city and county in the State as a part of the local peace officers organization. These organizations are considered adequate in this State, which is mainly agricultural.

West Virginia

Act authorizing the Governor to organize a State Guard passed by State Legislature but organization is still under consideration by State authorities. The State of West Virginia has a very effective police force equal to a National Guard battalion of infantry in number, and many of its industries have their own police force.

#### ACTIVE DUTY PERFORMED BY STATE GUARDS

The following is a resume of active duties performed by various State Guard organizations, unofficially or upon orders of their respective governors, in connection with civil disturbances, catastrophes, etc.

#### FIRST CORPS AREA:

Massachusetts

Guard duty and protection of property by approximately 125 officers and enlisted men at scene of fire in a manufacturing plant at Fall River, Massachusetts, October 12 to 14, 1941.

Rhode Island

Traffic and guard duty during and following a disastrous fire at world's largest cotton mill, Natick, Rhode Island, July 3 to 6, 1941.

## SECOND CORPS AREA:

New Jersey

Control of crowd at Newark Airport Show, September 14, 1941. Unofficial.

## THIRD CORPS AREA:

Maryland

Guard duty and first aid following explosion in Cumberland, Maryland, October 2 and 3, 1941.

## FOURTH CORPS AREA:

Alabama

Guard duty, patrols, and police duty during a civil disturbance at Anniston, Alabama, February 24 to March 8, 1941. Seventy men called.

Guard duty, patrols, and police duty at Gadsen, Alabama, during a civil disturbance, September 12 to 21, 1941. Also in Birmingham, Alabama from September 25 to 30, 1941.

Florida

Aid to civil authority in protection of life and property during a civil disturbance at Key West, Florida, July 28 and 29, 1941. One company employed.

Georgia

Assistance to police by guarding and patrolling water works and fair grounds in four Georgia towns, September and October 1941. Four units employed. Twenty-six units acted as auxiliary police at Selective Service registration booths, October 1941.

South Carolina

Guarding property two days, May, 1941, following an explosion at a small manufacturing plant at Orangeburg, South Carolina.

## FIFTH CORPS AREA:

Indiana

Policing of Motor Speedway during the 500-mile race on May 30, 1941. Also policed the Indiana State Fair grounds during annual roundup of saddle clubs.

Kentucky

Guard duty at Kentucky Derby, May 1941. Unofficial.

#### SEVENTH CORPS AREA:

Kansas

1 4 Miles 18

Guard and traffic duties during flood at Hutchinson, Kansas, October 23, 1941.

Minnesota

Duty in City of White Bear Lake, Minnesota, September 4 to 7, 1941, during cyclonic storm. One company active.

Two companies performed guard duty on occasion of the visit of the Duke and Duchess of Windsor to St. Paul, Minnesota, September 27, 1941.

Missouri

One battalion mobilized during civil disturbance in Kansas City, September 17 to 19, 1941, but no actual duty performed.

### EIGHTH CORPS AREA:

New Mexico

Guard and traffic duty during floods in various towns and cities in New Mexico during the period May 10 to middle of June, 1941, and on September 20, 21, 24 and 28, 1941. Nine companies participated.

Texas
