## FINDINGS OF FACT

- 1. The site of 640 acres was used through an informal agreement between the War Department and the U.S. Department of the Interior. Control of the site was never formally transferred to the War Department.
- 2. Victorville PBR No. 20 was obtained for use by the Army Air Forces based at Victorville Airfield as a practice bombing area. However, there is no evidence the site was ever used for this purpose, as indicated by the lack of remains of an asphalt target associated with the other PBR sites.
- 3. Victorville PBR No. 20 was informally transferred to control of the U.S. Department of the Interior on 1 November 1948 through a Letter of Transfer. Currently, most of the site is controlled by private land owners, however, the northeast quarter of the site is controlled by the U.S. Department of the Interior, Bureau of Land Management.

## **DETERMINATION**

Based on the foregoing findings of fact, the site has been determined to have been formerly used by the DOD. It is therefore eligible for the Defense Environmental Restoration Program For Formerly Used Defense Sites established under 10 U.S.C. 2701 et seq.

SITE NAME: Formerly Victorville Precision Bombing Range (PBR) No. 20.

LOCATION: The former Victorville PBR No. 20 is located approximately thirteen (13) miles northwest of Joshua Tree, California.

SITE HISTORY: No formal transfer or acquisition of property was ever obtained for Victorious PER No. 20. Victorious PER No. 20 was used through an informal agreement between the War Department and the U.S. Department of the Interior. The site was supposed to have been used as a practice bombing range by the Army Air Forces based at Victorville Airfield, however, no signs that the site was used as a bombing range were found during the site Currently, most of the site is owned by approximately 100 private land owners, however, the northeast quarter of the site is controlled by the U.S. Department of the Interior, Bureau of Land Management. Small block wall houses are scattered throughout the site except in the northeast quarter of the site which is undeveloped desert land. No DOD improvements were There is no visible evidence of unsafe observed on the site. debris, hazardous or toxic waste, or unexploded ordnance resulting from DOD use of the site. San Bernardino County Environmental Health and Fire Departments, the Regional Water Quality Control Board No. 7, and the George Air Force Base EOD Office records do not indicate any hazards associated with the site.


SITE VISIT: Dennis Parker and Paul Robinson, The Earth Technology Corporation visited the site on 21 November, 1988.



PROJECT DESCRIPTION: None




